August Program: Norm Lucas, Assistant Manager for Railroad Operations at the California State Railroad Museum, described CSRM's annual Polar Express excursions, and provided an in-depth look at the behind the scenes training, scheduling and volunteer efforts associated with the event. This is the seventh year of operation. They handle 1000 passengers per train, and it takes 55 volunteers per day to staff the 4 trains operated each day. Norm's presentation gave us all a greater appreciation for the amount of work that goes into staging the event each year. Thanks, Norm.

Fall Field Trip to Siemens Sacramento

Our fieldtrip is scheduled for Tuesday, October 15 at **3pm**. This is a reprise of our tour of the Siemens Plant a couple of years ago which was wildly popular by our Again, this tour will be led by Kevin members. McGrew of Siemens and will focus on the new Amtrak electric locomotives that Siemens is manufacturing for the US Northeast Corridor. The locomotive is called the American Cities Sprinter 64. 2013 Colfax Railroad Days Oct. 5-6

This year's event is packed with railroad-related displays and activities. California State Railroad Museum will be displaying SP6051, an E-9 diesel locomotive (see photo on page 3). Union Pacific is bringing snow removal equipment including a spreader and a rebuilt rotary plow if the unit is delivered in time. Retired UP employees will display maintenance of way equipment and explain their operation. We have commitments from four different model railroad groups and the rideon live steamers. Brendan will be screening railroad films of the Donner region. The caboose will be open to display status of our club-managed renovation.

This should be a great event and promises to build a solid foundation for future years, eventually leading to the establishment of an outdoor rail museum in Colfax.

Passing Scene - A bit of railroad history will return to the Donner Route in October when California State Railroad Museum displays its restored SP6051, E-9 Diesel locomotive at Colfax Railroad Days. Union Pacific will transport the E-9 to Colfax along with UP snow removal equipment including a recently rebuilt rotary snowplow that should be delivered this month.

SP6051 served on the Coast Daylight route between LA and San Francisco. Similar SP E units powered the City of San Francisco over Donner Pass. This particular locomotive was previously showcased in Colfax in 1993. It was then a featured attraction at the City's first annual Founders Day, celebrating the rich history of the area including the railroad through town. 

From the Archives

August Photo: The photo at right shows Emigrant Gap circa 1950. The buildings near the tracks housed or served railroad workers. The building at left was likely the store (the hotel next to the store was absent or not visible in this photo). The Tahoe Sugarpine Lumber Co. planing mill is above the tracks in the distance. Until the 1920's a 65-ft. Turntable was located in the clear area at lower right. The track and buildings at Emigrant Gap were under snowsheds in earlier days. A 1901 fire destroyed 2500 feet of snowsheds here including the shed covering the turntable. In 1922





a new 80 ft. Turntable and shed were built beyond the curve in the distance. The telegrapher's office was also located there. The balloon track replaced the turntable in the 1950's. Photo above courtesy of Herman Darr.

The photo at left shows the same location today. The buildings are gone, but graded areas show where buildings and the early turntable were once located. Photo at left by Roger Staab.

September Photo: This month's photo is not directly on the Donner Route, but the location was important to many who traveled by train over Donner. What is the building at right, and what was the significance of its location? Answers in the October newsletter.



CPRR/SP Donner Route Timeline: Improvements were needed almost immediately on some portions of the transcontinental route. By 1873 iron rail over Donner was being replaced with 60-pound steel rail. Trestles below Colfax and at Clipper Gap were filled in. At Deep Gulch east of Clipper Gap, one of the highest trestles on the line was abandoned when a new tunnel (Tunnel 0) was completed in 1873 and the trestle bypassed. Repairs to other trestles between Newcastle and Secret Town assured their safe use for at least 3-5 more years.
